

Five things will happen as a result of your gift to the Benson High Alumni Scholarship Endowment:

1. *Benson graduates will directly benefit.*

The immediate intent is to raise \$100,000 to support five or more scholarships to be awarded each year to Benson High seniors. The scholarships will be awarded to qualifying seniors on the basis of need. By continuing to add to the endowment, the intention is to increase the amount of each scholarship as well as the number awarded each year.

The Omaha Schools Foundation, an entity entirely independent of the Omaha Public Schools, will provide administrative services for the Endowment. At no cost to the Endowment, the Foundation accepts contributions, doing most of the work while an Alumni Association Committee, working with Benson's Director of Counseling, takes care of circulating the applications, making the selections, and presenting the scholarships.

The Foundation has 501(c)(3) tax status.

Planned giving and bequests are encouraged, as are scheduled monthly donations.

Why an Endowment Fund?

One of the long-term goals of the founders of the Benson High School Alumni Association, incorporated in 1987, was to establish a Scholarship Endowment Fund. Although scholarships have been awarded to graduating seniors each year since the beginning, those scholarships, as well as the amounts and the number awarded annually, have been totally dependent upon membership dues and spontaneous yearly monetary gifts by a few very generous alumni donors.
